Charitable Purposes

The charitable purpose of the society is to:

- Preserve the architecture, historic character and ambience of the Royal Burgh of Crail
- Improve and maintain the amenity thereof
- Co-operate with and support the work of the Trustees of Crail Museum

Structure and Management and Recruitment and Appointment of Trustees

The society is set up as an unincorporated charitable association, governed by constitution. At the Annual General Meeting, office bearers and committee members are appointed to run the day-to-day business of the society. Any member of the society is eligible to become a committee member or office bearer. Nominations are sought in advance of the annual general meeting at which elections are held and the results announced. The term of office is three years. All committee members are trustees of the Society. No committee member or office bearer has any right to appoint a committee member. No committee member or office-bearer receives any remuneration but reimbursement of reasonable expenses is allowed with prior authorisation by the Chairman or Vice Chairman and supported by receipts. Financial accounts are ratified by the members at the Annual General Meeting.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those relating to the operations and finances of the charity and are satisfied that systems are in place to mitigate the charity's exposure to the major risks.

Review of the Activities and Achievements

For this financial year CPS ended with a surplus of £6,400. Due to a strong level of Receipts of £23,176 primarily as a result of a final grant payment for the Lumsden Monument (£10,000) and a Common Good contribution (£3,114) for the Doocot refurbishment. However subscription membership and donations were stronger as we implemented our new CPS Online Membership program.

The **Lumsden** monument is located in the northwest corner of the Crail Kirkyard. The project finally closed out in May 2023 with CPS making the final retention payment to our main contractors, FA Sweeney.

Some interesting matters developed during the execution of the Lumsden monument.

Firstly CPS was offered funding by our FC Community Officer as the Graves Dressing Fund had an annual income of ~£10,000 and invested funds of over £360,000. This is good news and should mean we can continue with the Kirkyard campaign of works.

Secondly Historic Environment Scotland made us aware of the DCMS Memorial Grant Scheme. For work carried out on memorials it is possible to apply for grants to the value of all VAT payments made on all project components. This resulted in £7,442 funding for the Lumsden Monument.

Thirdly, we learnt that one of our contractors was willing to enable us to look after our stone assets locally. As such in November of 2023 we will have a local contractor trained by stone specialists, on general cleaning and biocide treatments, so that we can apply our own treatments to assets like the Doocot, Mercat Cross and the Kirkyard monuments.

The **Crail Mercat Cross** project was completed in the summer of 2022, however the final payment was not made until June 2023 as the retention amount came due. Funding for the project was received from:

Historic Environment Scotland £10,000

Fife Environment Trust (for SLCF) £3,445

Crail Common Good Fund. £10,000

VAT Memorial Fund Grants £3,958

Crail Museum and Heritage Centre also funded £2,580 towards the development of the interpretation panel for which we are really grateful.

Further to the DCMS Memorial Grant Scheme information above. The Mercat Cross has on its lowest north facing step a dedication to Queen Victoria. We asked the question as to whether the Mercat Cross becomes classified as a memorial. The answer was yes, and resulted in £3,958 of funding for the Mercat Cross project.

The **Doocot** continues as a very significant feature on the Fife Coastal Path. But sadly the exterior looked like it needed some TLC as we left winter behind earlier this year. A refurbishment program was carried out mid-summer, which was 50% funded by Crail Common Good Fund (£3,114) with a matching amount paid by CPS. Our contractors recommended that this is repeated every 2 to 3 years and not the 5 years we allowed it to languish this time.

As ever the **Denburn** Diggers have completed another year of outstanding work in Denburn Wood. An incredible amount of planting has taken place, which was very evident in the springtime.

Denburn Park (aka The Sheep Field) ended the year without it's shepherd tenants, we worked through a fair legal notification process over a period of years, so that we could bring this community asset back under our control. During the next few months we will develop a proposal for the future of this asset and will invite CPS members to review and comment on the proposal.

CPS as the owner of the museum buildings purchases the buildings insurance for 62/64 Marketgate, and is fully reimbursed by Crail Museum and Heritage Centre, this appears as Insurance Income in out Receipts and Payments section, an odd form of income to report.

Reserves Policy

The society maintains levels of reserves sufficient to meet fluctuations in its receipts and payments, fund future plans and provide cover against future contingencies and risks. The statement of balances shows £57,034 of bank balances at the year end.

9. Explanation of Funds

Purposes of Unrestricted Funds

Unrestricted funds are those that may be used at the discretion of the Trustees in furtherance of the objectives of the charity.

Purposes of Restricted Funds

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes.

The Kirkyard Fund - Crail Kirkyard (a Fife Council owned cemetery) contains some of Scotlands most significant mural monuments from the 16th and 17th centuries. CPS is committed to a campaign of conservation work that aims to retain the significant features of these monuments.

Denburn Park Fund - Denburn Park is a CPS owned asset, that CPS has plans to change from an agricultural field to a community asset with paths and a desirable green environment.

Mercat Cross Fund -The Crail Mercat Cross is a common good asset (owned by Fife Council) that needed conservation work completed and site changes to elevate its position in Marketgate.

Purposes of Designated Funds

Designated funds are not restricted but allocated by the Trustees to ensure that adequate funding is in place for certain projects.

The Doocot Fund - The Doocot is a CPS owned asset that was renovated to position it as a valued historical and educational visitor site on the Fife Coastal Path. It is now featured in a book titled "111 Places in Fife that you shouldn't miss".

Funds are required to ensure CCTV, electricity, lighting and annual structural maintenance are supported. Due to specific external funding received, the Doocot will become a Restricted Fund in FY2023/24.
