## 3. Membership Update

### 6. Bank Signatories and Authorisations

With the resignation of the previous Treasurer and the recent appointment of Dawn Black to the Treasurer role, there was a need to make changes in the formal arrangements with both banks. Management Committee authority was sought for this from all Trustees as follows:

1. <u>Royal Bank of Scotland.</u> The Committee considered the Resolution sought by the Bank i.e.

"We resolve that:

- the Bank can phone the individuals we've identified as 'Call Back Contacts' to confirm or correct any instructions or information that we've given the Bank
- and the current mandate will continue as amended."

<u>Decision:</u> a)The Trustees passed the above Resolution unanimously. The intention is to remove Lyall Dochard as a signatory and add Dawn Black as a signatory to our accounts. b)Derek White was authorised to complete the online form for these changes to be implemented.

# 2. Royal Bank of Scotland - Digital banking

The Committee also discussed the Society's arrangements for Digital Banking and resolved unanimously as follows:

<u>Decision:</u> Once the new Treasurer, Dawn Black, had been established as a signatory, she should apply for digital Banking access. Full authority was given for her to do this.
